

## **MERS/Missouri Goodwill Industry Donation Sweepstakes:**

### **I. NAME OF SPONSOR**

MERS/Missouri Goodwill Ind., AAA Travel, Automobile Club of Missouri, WSDZ AM Radio Disney (Hereinafter collectively referred to as "Sponsor").

### **II. ELIGIBILITY**

Sweepstakes are open to all legal residents of the 50 United States or the District of Columbia 18 years of age or older as of entry date.

Any individuals (including, but not limited to employees, consultants, independent contractors, and interns) who have, within the past six months, performed services for MERS/Missouri Goodwill Ind., AAA Travel of Missouri, and WSDZ AM 1260 Radio Disney, or supplying the prize, and/or their respective parent, subsidiary, affiliated and successor companies, and immediate family and household members of such individuals, are not eligible to enter or play. "Immediate family members" shall mean parents, step-parents, children, step-children, siblings, step-siblings, or spouses. "Household members" shall mean people who share the same residence at least three months a year.

### **III. HOW AND WHEN TO ENTER**

#### **NO PURCHASE NECESSARY. NO DONATION REQUIRED.**

We suggest donating a gently used item and completing an entry form at your nearest Missouri Goodwill Store (including 9 southwest Illinois locations), however, a donation is not necessary to enter the sweepstakes and will not improve your chances of winning.

Entries remain the property of Sponsor and will not be returned or acknowledged.

Sweepstakes begins Thursday, May 1, 2008 at 9:00 a.m. (central time) and ends Sunday, June 15, 2008 at 4:00 p.m. (central time).

One entry per day, per household

### **IV. HOW AND WHEN WINNERS WILL BE SELECTED AND NOTIFIED**

A total of three sweepstakes prize winners will be selected on Friday, June 20, 2008 following the end of the six-week promotional period ending Sunday, June 15, 2008.

Prize winners will be notified by telephone no later than 5:00 p.m. (central time) on Friday, June 20, 2008.

*Prize must be claimed within 30 days of end of sweepstakes and notification.*

Limit one prize per winner for this sweepstakes

Odds of winning depend on number of valid entries received.

### **V. PRIZE(S)**

Three (3) trips for four (2 adults / 2 children (age 9 or under)) to Walt Disney World in Orlando, Florida. Each prize includes 4 days / 3 nights accommodations in a Walt Disney World moderate resort, 1 room based upon 4 occupants (based on availability and Sponsor's choosing), round-trip coach airfare for 2 adults / 2 children from Lambert International Airport, St. Louis, MO to Orlando International Airport, Orlando, Florida and return, 4 park hopper passes (2 adult / 2 children).

**All travel must be booked through AAA Travel of Missouri. Package (including air) must be booked by December 31, 2008. Travel by June 30, 2009, black out dates are 11/17 – 11/26, 2008 inclusive and 12/17/08 – 1/2/08 inclusive.**

Approximate retail value of each trip will not exceed \$3,500.

Final actual value at time of booking and travel may be substantially more or less depending on dates of travel, point of origin and ticket availability. Some restrictions apply.

All expenses not specifically provided for herein are the winner's sole responsibility. Some restrictions may apply.

Federal, state and local taxes, if any, are the sole responsibility of the winner, who will receive an IRS Form 1099 reflecting the final actual value of any prize valued at \$600 or more.
